4. I have NOT, within the previous two years, been convicted of, plead “guilty” or “no contest”, to a violation of:
 - a. Any provision of the Kotzebue Municipal Code, Alaska Statute or federal law involving the illegal use, sale manufacture, transportation, or possession of Alcoholic Beverages, including underage possession of alcohol.
 - b. A DUI/DWI, or Refusal to Submit to Chemical Testing, including those alcohol crimes that only involve commercial vehicle.
5. I have NOT been issued a non-resident permit that has been previously suspended or revoked. However, if any previously issued non-resident permit that was suspended or revoked, I state that the period of suspension or revocation has expired, I have paid all fines due, and I have met all conditions imposed at the time of the suspension or revocation.
